Polymeric materials or articles do not contain monomers and other starting materials which are which are limited by Regulation (EC) No. 10/2011 and Regulation (EC) No. 1935/2004.

The product contains traces of Aluminium, which is regulated with a specific migration limit in EU (Commission Regulation 10/2011; Article 6.3.a and Annex II), Mercosur (Res. 39/2019 Annexo 4.3.b and Res. 02/2012 chapter 4b) and Switzerland (Bedarfsgegenständeverordnung 817.023.21, Anhang 2.3.1); (1 mg/kg expressed as Al). Representative worst case tests (3% acetic acid; 4h/100°C; S/V-ratio 6) did not show any migration above 0,04 mg/kg (limit of detection).

The product may contain a residual component from the catalyst system, which is regulated with a specific migration limit in EU, Mercosur and Switzerland. Migration tests in 95% Ethanol for 10 days at 60°C showed a migration level below the SML, so when applying a standard surface volume ratio of 6, this SML cannot be exceeded under any foreseeable conditions of use.

Other used monomers and additives are not regulated with specific migration limits.

Substances also authorised as direct food additives ("Dual use additives") are either not used for the manufacturing of this product.
